



## 2021–2022 Dependent Verification Worksheet

If eligible, enter your FSA ID and click the blue "LINK TO IRS" button. You will be asked to input your tax filing status and address to verify your identity. Please input your address exactly as it appears on your filed tax return. Once your identity is confirmed, select "Transfer Now" and follow the on-screen instructions to submit the FAFSA update. FAFSA updates should be received by the Financial Aid Office within 2-3 business days.

The student and one parent whose information was reported on the FAFSA must sign and date. If you purposely give false or misleading information, you may be fined, sent to prison, or both.
